Whereas TEQIP III Cell, NIT Srinagar placed an order for the supply of Triaxial Equipment for the Department of Civil Engineering, National Institute of Technology Srinagar with M/S ZS Infratest LLP, B 10 Zakir Bagh, New Delhi vide purchase order no. NIT/TEQIP/21/17 Dated 15-01-2021. As per the terms and conditions of the Standard Bidding Document, the bidder agreed to supply the equipment within the delivery schedule of 30 days in his letter of bid (Clause d) stating that:

*"We offer to supply in conformity with the Bidding Documents and in accordance with the Delivery Schedules specified in the Schedule of Requirements the following Goods and Related Services [Triaxial Equipment]"*

However, after the purchase order was issued, M/s ZS Infratest LLP, B 10 Zakir Bagh New Delhi through mail dated 19-01-2021 refused to accept the purchase order and showed inability to deliver the equipment within the specified time as mentioned in the Standard Bidding Document vide IFB no. TEQIP-III/2020/nits/313 dated 16-11-2020, Letter of Bid dated 17-12-2020 and purchase order vide no. NIT/TEQIP/21/17 dated 15-01-2021.

Hence, in accordance with Clause No. 19 of Standard Bidding Document vide IFB no. TEQIP-III/2020/nits/313 dated 16-11-2020 and pursuant to the approval of competent authority, the purchase order issued to M/s ZS Infratest LLP, B 10 Zakir Bagh New Delhi, stands cancelled and the bid security for an amount of Rs 1,00,000.00 (Rupees One Lac Only) furnished by the bidder through NEFT dated 15-12-2020 is hereby forfeited. Moreover, as also approved by the Competent Authority, M/s ZS Infratest LLP, B 10 Zakir Bagh New Delhi, is debarred/blacklisted for the participation in any tender/bid to be published by the Institute for the period of two years from the issuance of this order.
