Applications are invited for the post of 01 JRF in ICMR, Govt. of India funded Extramural Ad hoc project entitled "**Investigations on selective proliferation and transport of Antibiotic-resistant bacteria by microplastics**" under the Principal Investigator, **Dr. Khalid Muzamil Gani** and Co-PI **Dr Munir Ahmad Nayak**.

Qualification: M.E./ MTech. in Civil Engineering / Environmental Engineering / Chemical Engineering from a recognized university with minimum 70% aggregate marks (CGPA \geq 7.5/10) to qualify under Open/OBC category and minimum 65% aggregate marks (CGPA \geq 7.0) for candidates under SC/ST/PWD category. (Preference will be given to GATE, CSIR-/UGC NET qualified candidates).

OR

Post Graduate Degree in Biotechnology /Microbiology/ Biochemistry with minimum 70% aggregate marks (CGPA \geq 7.5/10) to qualify under Open/OBC category and minimum 65% aggregate marks (CGPA \geq 7.0) for candidates under SC/ST/PWD category. Must have Qualified CSIR-UGC NET or GATE

Desirable: Experience in working with microplastics /biofilms / biological wastewater treatment/ antimicrobial resistance. Analytical skills are microbial community analysis and water quality analysis. The project involves fair amount of fieldwork and candidate should be willing to do it. Interest for admission to Ph.D. program as a regular full-time subjected to satisfying the eligibility criteria of NIT Srinagar.

Personal attributes: - Self-motivated of learning and career orientation to academia.

Age limit: Upper age limit is 30 years on last date of application with age relaxation as per Govt. Rules.

Nature & Period of Post: Appointment as JRF initially for a period of one year with a possibility of extension for second and third year. The Extension is subjected to satisfactory performance and release of grant.

Fellowship: Rs. 31,000/- (Rupees thirty-one thousand) + 18% HRA according to terms and conditions as per the ICMR, Govt. of India.

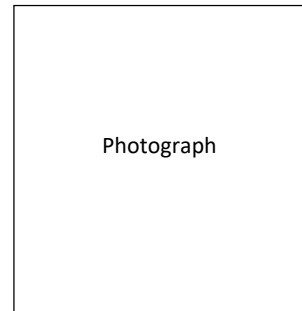
