Ministry of Water Resources, Government of India has set up a "CHAIR PROFESSOR titled "SHEIKH NURUDDIN CHAIR FOR WATER RESOURCES at National Institute of Technology (NIT) Srinagar, for carrying out the studies in Water Resources with emphasis on impact of Climate Change on it and adaptation of strategies in respect of Planning and Management of Water Resources Systems of particularly, INDUS BASIN. To fill up the Chair Professor Position on Contract basis, applications are invited from the eligible interested candidates.

Eligibility:

- 1. The candidate should possess ten years after Ph.D. or thirteen years total working experience, out of which seven years should be after Ph.D. At least three years at the level of Associate professor or equivalent in an Institution of repute or Research & Development lab or relevant industry. The candidates should have First Class Bachelor's Degree in Civil, Environmental, or Agricultural Engineering and First Class Master's Degree in Water Resources Engineering / Hydrology / Environmental Engineering / Irrigation and Water Management.
- 2. The candidate should have made significant contribution in the field of Water resources in terms of Research and Development, Project formulation, Coordination of R&D Activities.
- 3. The existing Professors/Associate Professors of the Institute with above relevant qualifications & experience can also apply to work on the basis of a top up salary for this additional assignment.
- 4. The already superannuated Professors of the relevant field & experience and fulfilling other requirements can also apply for the said Chair Professor position.

Duration and upper Age Limit:

Tenure of appointment to the Chair will be initially for duration up to 05 years, which may be extended. The upper age limit for occupying the Chair will preferably be 65 years.

Salary:

1. The top up salary for Professor & Associate Professor will be Rs. 35,000/- and Rs.30,000/- respectively

Other:

1. In addition to the above, the Chair Professor shall be subject to the conditions approved by the Board of Governors of NIT Srinagar & the charter laid down in the MoU with the

Ministry of Water Resources, Govt of India.
