Ministry of Water Resources, Government of India has set up a 'PROFESSORIAL CHAIR' entitled "SHEIKH NURUDDIN CHAIR FOR WATER RESOURCES at National Institute of Technology (NIT) Srinagar, for carrying out the studies in Water Resources with emphasis on impact of Climate Change on it and adaptation of strategies in respect of Planning and Management of Water Resources Systems of particularly, INDUS BASIN. To fill up the <u>Position of Consultant</u> on Contract basis, applications are invited from the eligible interested candidates.

Eligibility:

- 1. The candidate should possess minimum Master's Degree in Water Resources Engineering / Hydrology / Environmental Engineering / Irrigation and Water Management with Bachelor's Degree in Civil, Environmental, or Agricultural Engineering.
- 2. The candidate must have an experience of minimum 05 years Teaching / Industry / Research. However, for a candidate with Ph.D. Degree the condition of experience is exempted.
- 3. The existing Professors / Associate Professors of the Institute with above relevant qualifications & experience can also apply to work on the basis of a top up salary in the shape of honorarium for this additional assignment.
- 4. The already superannuated Professionals of the relevant field & experience and fulfilling other requirements can also apply for the said Consultant position.

Honorarium:

- 1. For Full time Consultant Rs.70,000/- per month (consolidated).
- 2. Top up Honorarium for a Working Professors Rs.20,000/- per month and for an Associate Professor as Rs.15,000/-
